INDEMNITY

FEES

Insurance and registration fee is payable upon offer of enrolment. 2023 Insurance and registration fees are \$85 per child enrolled. Enrolment will not be confirmed until Registration Fee is paid. Parents/Guardians are fully responsible for the tuition payments in accordance with CITY STUDIOS TOWNSVILLE tuition policy. Tuition is non-refundable and is due in full at the beginning of each term in which the student is enrolled even if a student withdraws from classes, with the exception of withdrawal being due to a prolonged illness, serious injury or a family move which must be confirmed with appropriate documentation from a physician or company, whichever the case may be.
